Sub: Extension of Provisional Affiliation to the above said school (Affiliation no. 1030482) beyond 31.03.2018-reg.

Sir/Madam,

This is with reference to your online application registered on 30/06/2016, on the above subject.

In this connection, I am directed to convey the sanction for extension of provisional affiliation of the school with the Board for its **Secondary School Examination and Senior School Certificate Examination** for a further period of **five years w.e.f. 01.04.2018 to 31.03.2023** subject to the fulfillment of the following conditions:-

- 1. The School is required to abide itself by the Examination/Affiliation-Bye-Laws of the Board.
- 2. The School is required to apply on online for further extension of affiliation along with the requisite fee and other documents by 30th June of the preceding year in which the Provisional Affiliation expires as per Rule 15.11 of Affiliation Bye Laws.
- 3. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X vide Circular No. 39/20-09-2009 dated 20.09.2009 in the school and further directions issued from time to time.
- 4. The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.
- 5. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt from time to time.
- 6. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under <u>from Pre-Primary to Class XII</u> :-

- (d) School running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.
- (e) Schools running on less than 01 acre campus shall restrict number of students as follows:-

(ii) Sr. Secondary School with two streams 3000 sq. mtr. 900 to Class XII The school should scrupulously observe prescription from the Municipal Authority/District Collectorate/Transport Department regarding drinking water, fire safety and transport precautions in the school. A certificate from the Municipal/Fire/transport Authority regarding sanitary conditions, water/fire/transport safety should be submitted every five years as per Rule 8.5 of Affiliation Bye Laws and shall follow Rule no. 3.3(vii) and Rule 23(xi) in this regard.

- As per RTE act 2009 and Chapter IX rule No. 53.2.2(a) and 53.3, a teacher appointed to 33. teach Class I to V and VI to VIII should pass in the Central Teacher Eligibility Test (CTET)/ State Teacher Eligibility Test (TET) conducted by the appropriate Government in accordance with the guidelines framed by the NCTE for the purpose.
- 34. 5-6 names of persons not below the rank of Principal of Sr. Secondary School affiliated with the Board be recommended so that two of them may be approved by the Board as its nominee in the School Managing Committee (Of these 2-3 may be Principal of KV/JNV).
 - The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws. 35.
- 36. It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.
- The Board would not allow any transfer of property/sale of school by one society/ 37. Management/ Trust to another Society/Management/Trust through agreement/sale deed and the school shall not be closed down in the same premises. In case such transaction is effected explicitly or implicitly the Board shall withdraw its affiliation with immediate effect.
- The school should keep a copy of Affiliation/ Examination Bye Laws for reference purpose 38. and also advised to visit CBSE websites www.cbseaff.nic.in & www.cbse.nic.in for updates.
- In case of established violation of the provisions contained in Affiliation/Examination Bye 39. laws of the Board, the school shall be liable for disaffiliation as per Rule No. 17 of Affiliation Bye-laws.
- 40. Special conditions to be complied within three months:
 - a. School Managing Committee is to be re-constituted as per Affiliation Bye-laws, by including 02 representatives each of teachers and parents, 2 CBSE representatives from KVs/JVNs not below the rank of Principal of Sr. Secondary School affiliated with the Board. Nomination should be from recommendation of the Board and also ensure that no blood relation is in it. (for this school may submit the penal of Principal of KVs/JNVs to Board).
 - b. The school is required to furnish valid latest Sanitary Conditions, Safe-Drinking Water, Fire Safety Certificates issued by the competent authorities/concerned department.
 - c. The school is required to submit a renewal copy of EPF. A documentary proof regarding implementation and regular deduction of EPF is required alongwith latest pay Bill and Bank Challan.
